Rockefeller Raps Chicago Diversion

WASHINGTON (AP)—Gov. Nelson A. Rockefeller of New York said today any additional diversion of Lake Michigan water would cost users of the Great Lakes and St. Lawrence Seaway millions of dollars annually.

Rockefeller assailed bills before Congress that would allow Chicago to divert more Lake Michigan water into the Illinois Waterway for sanitation.

"THE GOVERNOR said the bills 'were drafted without regard for the rights and property of the people of New York...'

Rockefeller made the remarks in a statement to the Senate Public Works Committee by J. Burch McCormack, state public works superintendent. More than two dozen witnesses, mostly opponents, were scheduled to testify.

The Chicago Sanitary District presently is limited by a 1938 U.S. Supreme Court decree to a diversion of 1,000 cubic feet per second, plus domestic pumpage. New York, other Great Lakes States and Canada have been fighting attempts for years to increase the amount.

Rockefeller pointed out that the New York State Public Works Board had constructed one project along the St. Lawrence River at Massena and was constructing another at Niagara Falls.

He said these projects were financed on the assumption that St. Lawrence and Niagara water would be diminished.

"Any reduction in the amount of water available for power will reduce the revenue of the power authority, which necessarily will increase the cost of electricity to its consumers," he said.

"The Great Lakes are now in low elevation," Rockefeller said, "and we need all the water available for the production of power."

He said it appeared that the proponents of the diversion were only interested in benefiting the Chicago Sanitary District but cutting the cost of sewage treatment and by increasing income from hydraulic power generated at

Dirksen Says Ike Should Veto TVA Bill

WASHINGTON (AP)—Senate Republican Leader Everett M. Dirksen of Illinois said that if he were president he would veto a bill to authorize self-financing for the Tennessee Valley Authority.

The House and Senate have passed in slightly different form measure to permit the TVA to issue bonds up to \$20 million dollars to finance construction of needed power facilities.

Dirksen, apparently reflecting President Eisenhower's attitude, told reporters the administration's objection to the bill is a provision which would allow the TVA virtually to bypass the White House and Budget Bureau in determining its budget outlays.

The governor said that if Chicago could solve its sewage treatment problem without diverting more water by means of chlorination and aeration at an average cost of one million dollars a year, "the governor said that if Chicago were allowed to solve its sewage problem by diverting additional water, 'It will cost the users of the Great Lakes...'

CAP Surveys Cross Country Plane Traffic

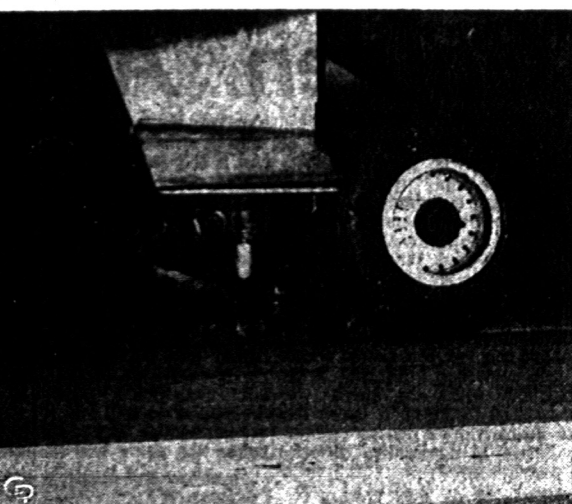
