FILIPINO FORCES AWAIT INVADERS

Tattered North African Armies In New Retreat

Hitler's Forces Fail To Give Battle At Agedabia, Libya

BULLETIN

Kulbyshev, Russia, Jan. 7—(Delayed)—The Russian defenders of Sevastopol are breaking the German siege of that Black Sea naval base and have launched a new offensive in the campaign to drive the invader out of the Crimea.

Military dispatches said today that Russian troops advancing from the hill approach to Sevastopol were crushing the German positions—now hurriedly converted from offensive to defensive functions—and that despite prevailing storms the Black Sea fleet was cooperating in the operation.

Axis Hitler's tattered North African armies have started a new retreat on the west-bound road to Tripoli, the British announced today, and British spearheads now are operating 600 miles from the starting point of the drive into Libya.

A bulletin from British middle east headquarters said the axis forces, which failed to give battle at Agedabia, 90 miles south of Benghazi, were falling back under cover of a blinding sandstorm.

The communiqué said British mobile columns were in pursuit, slaughtering at the axis flanks and rear. More good news came from the Soviet battlefield, with Russia's armies officially reported to have advanced within 40 miles of the Vyazma-Bryansk line on which the Germans had been expected to attempt to dig in for the winter.

Soviet dispatches said Russian troops had driven wedges more than half way through Nazi defenses on the central front, ranging from the Volga to the Carpathians, including systems of camouflaged dugouts heated by stoves and covered with six or seven tiers of logs.

Long Winter's Stay
The dispatches did not say whether these were outposts or part of the main German defense, but certainly indicated that the invaders expected a long winter's stay.

London newspaper reports said machine gun posts were being set up at strategic points in Berlin, manned by Hitler's own SS (elite guard) troops, as a precaution against a coup d'état, but a British foreign office spokesman warned that reports of a possible internal upheaval in Germany should be treated with reserve.

4 Indicted By Grand Jury For Crimes

Since the war in Europe began two years ago, the cost of producing a newspaper has risen very rapidly.

One of the first costs to be increased was that of news service. In addition, there have been sharp rises in the costs of linotype, stereotype and engraving, metal, labor, taxes, all machinery and equipment, in fact every item of expense that goes into the production of a newspaper.

British Fall Back Under Jap Pressure

Establish New Line In Northern Selangor Province, Malay States

Singapore, Jan. 8—(AP)—The British acknowledged tonight that they had withdrawn from Perak province on the west coast of Malaya falling back under heavy Japanese pressure to a new line in northern Selangor province guarding Kuala Lumpur, capital of the federated Malay states and second city of British Malaya.

A communiqué which announced the withdrawal said it was made necessary by a Japanese penetration of the lower Perak defense line. It added that "we suffered some losses in guns and transport" in the withdrawal.

New Defense Line
The new defense line was south of the Selim river, a Bernam river tributary dividing Perak and Selangor province. The Selim river is 50 miles north of Kuala Lumpur and 200 miles north of Singapore.

Even this stand, the communiqué indicated, might be imperiled by Japanese forces who infiltrated earlier down the coast to the Kuala Selangor area 35 miles northwest of Kuala Lumpur.

The communiqué said there were "some indications of enemy infiltration eastward" from this area. Such an operation eastward apparently would cut in behind the Selim river defense line.

From the Selim river the battle-line extended unevenly across the interior, through Pahang state to the east coast, somewhere between Kuantan, 120 miles north of Singapore, and the Pahang-Johore border, little more than 75 miles from this island stronghold. The British have admitted merely that they have withdrawn from Kuantan. (Axis reports have placed the Japanese at the Johore border, but the British deny this.)

Some Casualties
Reports from Klang, west of Kuala Lumpur toward the Malacca strait, said there had been some casualties in Japanese air raids Tuesday.

British bombers were said to have carried out a new raid on the Japanese-held airbase at Gong Kedah.

Defense forces imposed a curfew on Kuala Lumpur and its residents were ordered to stay in their homes between 6 p. m. and 8 a. m.

(Lord Moyne, British colonial secretary, said the Japanese had advanced to a point 60 miles north of the city.)

Mine Sweeper Sinks; 8 Men Drowned

Portsmouth, N. H., Jan. 8—(AP)—Army officials said today that eight men drowned in the Atlantic 20 miles off the Isles of Shoals early today when the 98-foot mine sweeper Arnold sank while being towed to port.

The names of the victims were not available immediately but they were believed to be civilians. The only survivor was the Arnold's master, William H. Chasteen of Watford, Conn.

The Arnold had been dispatched yesterday to the assistance of another mine planter the L-58. With the aid of an army plane which flew over the area, the Arnold located the L-58 and started to tow her to shore.

Later a mine sweeper met the two smaller craft and began towing both of them.

Suddenly, the Arnold sprang a leak while the three ships were being pounded by heavy seas.

State Employee, Discharged, Files Appeal

Whereabouts Of Pacific Fleet Worries Japs

Seek Information By Spreading Phony Reports Of Sea Action

Washington, Jan. 8—(AP)—The war department said today that defenders of the Philippines were bracing themselves for a large scale general attack by the Japanese invaders.

General Douglas MacArthur, Far East commander, personally directing the fighting men drawn together north and west of Manila bay, reported that more and more Japanese troops were high and declared they will "continue their resistance with skill and courage."

There was fighting of "varying intensity" on all sections of the Luzon front, the war department said, but the lack of enemy bombing and aerial machine gunning recently indicated the Japanese probably were drawing up their strength for a vital blow.

Today's Communiqué
The text of the morning communiqué, number 51, based on reports received here up to 8:30 a. m., contains standard type:

"1. Philippine theater: Fighting of varying intensity is reported from all sections of the front. These operations are probably preparatory to a large scale attack by the enemy. Japanese reinforcements are being brought up to the front and indications point to a renewal of the offensive by the enemy. General MacArthur reports that the morale and determination of the American and Philippine troops are high and that they may be counted on to continue their resistance with skill and courage in Tokyo."

"2. There is nothing to report from other areas."

The morning communiqué was read at a press conference in which John J. MacCloy, assistant secretary of war, told the writers that American losses in the Philippines had not been "unduly heavy." General MacArthur has reported that Japanese losses were far higher, MacCloy said.

Fleet Location Causes Concern
The whereabouts and intentions of the United States Pacific fleet apparently were causing renewed concern today in Tokyo.

There was evidence of this in the enemy's recourse to the axis press technique—the circulation of vague reports designed to elicit valuable information.

Both the Tokyo radio and a German-controlled station cooperated in broadcasting the initial feints. Tokyo was heard reporting an engagement between the Japanese and American fleets in the western Pacific. The Japanese, it was said, had the Japanese attacking two U. S. battleships en route to Australia, and sinking one of them.

The will bears the date of Feb. 15, 1933 but county court death records show that George W. Faber, whose name as a witness is added, died Feb. 16 of that year.

Both Mr. Faber and W. H. Sawyer, whose name also appears as a witness, are deceased.

Providence, R. I., Jan. 8.—(INS)—It requires brains as well as brawn, and books as well as iron and steel, to push the nation's defense effort into high gear.

The Physical Sciences Division of Brown University reported that never in its history has there been such a demand for reference material dealing with scientific, technical and industrial matters.

Requests come largely from research men and technicians connected with the defense industries in southern New England, including the Naval Torpedo Station at Newport, according to Dr. Henry B. Van Hoesen, university librarian.

"There has been a greatly increased demand for books on aircraft design, maintenance and other phases of the aircraft industry, as well as for books on the theoretical side of aviation," Dr. Van Hoesen said. "There has also been an increased demand for books on industrial management."

"Requests for information that have come up most frequently have been on poison gases, American equivalents of certain British standards specifications, uses that could be made of certain by-products and waste materials from local industries, industrial applications of ultra-red rays and stress corrosion."
